Discussion Points/Decisions

- Inclusive leadership programme group pleased to see that both Hannah Pretty & Zoe Brown from WA were on the programme. Suggestion that they present back to the group plus SMT at an appropriate point in the future as course progresses.
- Agreed that communication of data on ED&I within athletics in Wales back out to the
 community should be accompanied by case studies highlighting existing good practice.
 E.g. Cardiff Foxes running group use during LGBT month [Feb'22] SDA suggested
 case studies also be sent to Sport Wales for publication via their channels where
 possible.
- Watching brief to be maintained on progress with implementation of the Transgender inclusion in sport guidance.
- Ensure we are communicating why EDI action is important as well e.g. wider audience, new 'customers'
- Ongoing need to focus on ED&I during staff and governance recruitment.
- New version of Advanced level Equality Standard in Sport still be released RS to follow up with Sport Wales.
- Possible new members of the group being approached are Richard Dando [previously Sport Wales] and Neil Taylor new Para-athletics pathway manager for WA.
- Look at gap analysis in terms of multiple deprivation areas provision & take up of school's athletics opportunities.

ED&I strategy and plans

- James Williams outlined process for consulting on and reviewing the current Welsh Athletics strategy. Timescale covered will still be until 2026.
- Production of a separate document to the soon to be updated overall Welsh
 Athletics strategy should be undertaken. Will bring a focus on ED&I and be more
 digestible for the community the FAW Pawb document was referenced as a good
 example.
- Workshop with group members to be planned for April 2022 to produce draft document. Current strategic goals and suggested KPIs document to be reviewed by members over the coming weeks
