Key Points/Decisions

- The group welcomed Michael, and Rebecca and were supportive of the involvement of Welsh Athletics in working with RDK and Sport Wales to develop learning and networks around governance of sports bodies in Wales.
- The independent review report was highlighted by TC as being very positive, and the group agreed it should be made public for the membership to see. The group asked for an action plan linked to the recommendations to be published at the same time and for this to happen as soon as possible.
- The group discussed and agreed the job role descriptions for two board roles; NED HR & Legal, and NED Marketing & Comms. The group expressed desire to see the roles advertised as broadly as possible and for positive action in relation to diversity to be considered. It was agreed the adverts should be circulated to clubs.
- In relation to the secondment of an individual to support the Performance Sub Group over the next 12 months, the group asked for WA to ensure this was as transparent as possible and that another member of the board not on the PSG be involved in the process.
- The group agreed the new Withdrawal of Awards policy subject to minor wording changes, the most significant being the following:

"Any individual who falls into the following category could be deemed ineligible for a Welsh Athletics Award, or who could be considered to have their award annulled;"

"In writing" to be replaced with "communicate formally" with the following footnote: "This must be auditable but could be in hardcopy, email, video recording, or audio recording with proof of identity."
