Update on Actions reviewed from previous meeting:

- SM/ZH will discuss priorities for future meetings identifying appropriate co-opted members
- Welsh official's selections for specific roles at the indoor Senior/Junior Champs. Closed
- Field request reports will be looked at within Outdoor events.
- Official's courses to be on line with local based face to face courses.
- Conference ideas to ZH/SM/SH. Closed

Key Points discussed/Decisions made

- 1 Concern over low Officials Conference numbers. Another social media/web push to to increase numbers. Top tips from various disciplines along with TM/COC roles to be presented. DSW presentation regarding Autism awareness.
- 2 Officials/Volunteer development day updates
 - a. South & East Region are holding a joint day on the 20th March at Aberdare, ZH & Joyce Tomala will be the main points of contact.
 - b. West Region will be holding their event within the Swansea Open on April 3rd, JE will be inviting parents to come along to work alongside experienced officials.
 - c. ZH confirmed that one will also be held in the North on the 13th March.
- 3 Reports for officials to be looked at from availability forms sent through.
- 4 Clarification sought on feedback loop from main WA events that Officials submit, where do they go. They were previously on Trinity like the UKA events.

- Peter Gregson (CAAC) attended the meeting to help inform a discussion on recruiting officials at grass roots. Very difficult at the moment but parents are starting to drift back. Ideas included:
 - o From CAAC: discount membership scheme, official's kit, official's clipboard/pens.
 - o For consideration by WA in leagues: Points system for the number of officials a club supplies pro-rata based on club size (rather than deductions). Could be accumulated leading to a prize at the end of the season eg trophy/voucher for equipment.
